- Any LSG decision to commercialize any product will receive careful consideration of the risks and the benefits of
 the technology in light of the information available. The ability to perform an activity will not automatically justify
 the activity. As a company, these principles and processes govern our efforts to research, develop, and provide
 products.
- LSG listens to and considers feedback, and responds to concerns about the social, ethical, and technical
 application of biotechnology in the research, development, manufacture, and sale of our products. LSG's
 response to these concerns will be based on ethical considerations and scientifically sound hypotheses, theories,
 and data.
- LSG complies with applicable legislation and regulatory requirements and supports accepted ethical and professional standards in the research, development, manufacture, and sale of its products. Specifically, LSG is sensitive and responsive to concerns related to the conduct of all research on humans
- LSG is committed to protecting the life, health, privacy, and dignity of those participating in clinical trials, as well as to protecting the integrity of the data obtained from these studies.
- LSG supports the conscientious use of animals in research. To the extent possible,
- LSG will minimize the use of animals in our research, avoiding waste, and, where utilized, will treat them humanely and with the highest standards of care.
- LSG recognizes that protecting the environment and maintaining the biological diversity of our planet is of vital
 importance to human life. LSG believes in the importance of maintaining global biodiversity and sustainable use
 of global resources.
- This bioethics standard applies to work performed at the direction of LSG by external contract research
 organizations, consultants, and third-party vendors. Where LSG performs as a third-party vendor, LSG will take
 into account the bioethical conduct of the contracting organization in determining whether or not to take on the
 work.
- This bioethics policy and the decisions that have been made under its guidelines will be reviewed and revised as appropriate based on technological advancements, legal and regulatory changes, and current social and ethical considerations.
